





BYLAW NO. 118-11

BYLAW OF THE RURAL MUNICIPALITY OF GULL LAKE NO. 139 AUTHORIZING
FINANCIAL CONTRIBUTION IN THE REGIONAL PARK AUTHORITY OF ANTELOPE
LAKE PURSUANT TO THE REGIONAL PARKS ACT 1979.


The council of the Rural Municipality of Gull Lake No. 139 in the Province of Saskatchewan enacts and approves the following:

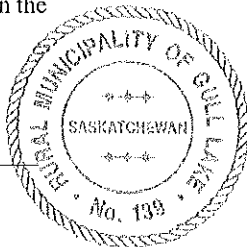
1. The participation in a development plan for new capital development in the Antelope Lake Regional Park, as outlined in the development plan identified as Schedule "A" to this bylaw.
2. The financial participation in the capital development program with other municipalities as outlined in the financial cost-sharing program as outlined in Schedule "B" to this bylaw, to commence in January 1, 2011.
3. The annual financial contributions, per year, for a term of five (5) years, commencing January 1, 2011, shall be as follows:
 - (a) capital development Five Hundred and Eighty Five-- 33/100-- dollars (\$585.33).
 - (b) maintenance and operating expenses Six Hundred and Seventy Four -- 19/100-- dollars (\$674.19).
4. That application be made under the provisions of section 5 of the Regional Parks Act 1979, in the form attached as Schedule "C" to this bylaw.
5. Bylaw No. 92-06 is hereby repealed.
6. This Bylaw comes into force and takes effect on the day of the final passing thereof and shall remain in effect until such time as the bylaw is repealed.


Please find enclosed the proposal along with your contribution for capital and maintenance annually for the next five years. You will note that no changes have been made from the last five year agreement with us.


