

Bylaw Number 67-01

A Bylaw of The Rural Municipality of Gull Lake No. 139 to provide for entering into an agreement respecting the provisions for providing Ambulance Services.

1. The Council of The Rural Municipality of Gull Lake No. 139 is hereby authorized to enter into an Agreement attached hereto and forming part of the Bylaw and is identified as Exhibit "A", with the following municipalities.


- Town of Gull Lake

- Rural Municipality of Webb No. 138
- Rural Municipality of Pittville No. 169

for the purpose stated within the agreement.

2. The Reeve and the Administrator of the Rural Municipality of Gull Lake No. 139 are hereby authorized to sign and execute the attached agreement, identified as Exhibit "A".
3. This Bylaw shall come into force and take effect on the day of the final passing thereof and shall remain in effect until such time as one of the parties to the agreement requests a review of the terms of the Bylaw in any year that a reassessment of the municipalities occurs.
4. Bylaw No. 26-94 is hereby repealed.





Exhibit "A"
Pertaining to a Bylaw to establish a Road Ambulance Services
Multi - Municipality Agreement

THIS AGREEMENT MADE BETWEEN:

- The Town of Gull Lake
- The Village of Tompkins
- The Village of Carmichael
- The Rural Municipality of Carmichael No. 109
- The Rural Municipality of Webb No. 138
- The Rural Municipality of Gull Lake No. 139
- The Rural Municipality of Pittville No. 169

WHEREAS

- A. The Parties of this agreement are municipalities as defined under The Urban Municipality Act, 1984 SS 1984, C.U-11 and under The Rural Municipality Act, 1989, SS 1989 C.R-26.
- B. The parties to this agreement wish to re negotiate the terms/conditions of the Gull Lake and District Ambulance Corporation to serve the above municipalities.

NOW THEREFORE this agreement witnessed and the parties hereto agree and covenant, to establish and authorize the functioning of a District Road Ambulance Corporation on the following terms and warranties:

1. *Gull Lake & District Road Ambulance Board*
 - The parties agree to appoint members to the board in a timely manner in accordance with the terms of the agreement.
 - The board will consist of one councillor or alderman appointed from each council in our ambulance area.
 - The board will consist of seven (7) members, two of which will be chosen as Chairman and Vice-Chairman by the members of the Board.
 - Term of office will be two (2) years.
2. *Administration and Management*
 - an Ambulance coordinator to be appointed by the Board as Chief Executive officer (CEO)
 - CEO to be responsible to administrate and manage all business conducted under the Ambulance Agreement
 - the CEO will be responsible and accountable to The Gull Lake and District Road Ambulance Corporation Board of Directors
3. *Finance*
 - Grants from the Rolling Hills Hospital District or a re aligned hospital district or from the Province will be used by the Board for Ambulance related expenditures.
 - shortfalls in funding - municipal appropriation to the corporation will be based on sixty per cent (60%) current population and forty per cent (40%) current assessment
 - Signing Officials - CEO and Chairman or Vice Chairman
 - Any of the parties to the agreement may request a review of the terms of the Bylaw in any year that (a) there is a change in funding from the Hospital District (Presently Rolling Hills) or (b) the operations change i.e no long hauls or (c) a reassessment occurs.
4. *Insurance and Licenses*
 - replacement insurance on Ambulance
 - Ambulance license requirements
 - liability insurance
 - employee insurance
 - employee benefits (SAHO membership)
 - all the above to be the responsibility of the corporation

Page Two to Exhibit "A" Multi Purpose Agreement for Ambulance Services

- 5. *Budget and Ambulance Rates*
-a budget and rate schedule is to be prepared annually by the CEO and presented to the Board of Directors for approval.
- 6. *Office Space & Equipment*
-to be located in the Gull Lake & District Emergency Services Building
-stationary and postage to be provided from the Board's Annual Budget
- 7. *Funding*
-all requests for funding shall be paid as soon as possible
