

BYLAW NO. 72-3

A bylaw for the purpose of giving approval to an agreement to establish and operate a regional park under the provisions of The Regional Parks Act.

The Council of R.M. of Gull Lake No. 139 in the Province of Saskatchewan, enacts as follows:

1. That the municipal agreement between the following municipalities:



MUNICIPAL AGREEMENT

THIS AGREEMENT made this            day of                            A.D. 19 .

BETWEEN:

THE RURAL MUNICIPALITY OF CARMICHEL NO. 109, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "R.M. of Carmichel"

the party of the first part  
- and -

THE RURAL MUNICIPALITY OF GULL LAKE NO. 139, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "R.M. of Gull Lake"

the party of the second part  
- and -

THE RURAL MUNICIPALITY OF WEBB NO. 138, a municipal corporation of and in the Province of Saskatchewan, hereinafter referred to as "R.M. of Webb"

the party of the third part  
- and -

THE RURAL MUNICIPALITY OF RIVERSIDE NO. 168, a municipal corporation of and in the Province of Saskatchewan hereinafter referred to as "R.M. of Riverside"

the party of the fourth part  
- and -

THE RURAL MUNICIPALITY OF PITTVILLE NO. 169, a municipal corporation of and in the Province of Saskatchewan hereinafter referred to as "R.M. of Pittville"

the party of the fifth part  
- and -

THE RURAL MUNICIPALITY OF MIRY CREEK NO. 229, a municipal corporation of and in the Province of Saskatchewan hereinafter referred to as "R.M. of Miry Creek"

the party of the sixth part  
- and -

THE TOWN OF GULL LAKE, a municipality within the Province of Saskatchewan, hereinafter referred to as "Gull Lake"

the party of the seventh part  
- and -

THE VILLAGE OF TOMPKINS, a municipality within the Province of Saskatchewan, hereinafter referred to as "Tompkins"

the party of the eighth part  
- and -

THE VILLAGE OF CARMICHEL, A MUNICIPALITY WITHIN THE Province of Saskatchewan, hereinafter referred to as "Carmichel"

the party of the ninth part  
- and -

THE VILLAGE OF WEBB, a municipality within the Province of Saskatchewan, hereinafter referred to as "Webb"

the party of the tenth part  
- and -

THE VILLAGE OF HAZLET, A municipality within the Province of Saskatchewan, hereinafter referred to as "Hazlet"

the party of the eleventh part  
- and -

THE VILLAGE OF ABBEY, a municipality within the Province of Saskatchewan hereinafter referred to as "Abbey"

the party of the twelfth part.

WHEREAS the parties desire to associate with each other for the purpose of establishing and operating a regional park (hereinafter referred to as "the park") pursuant to the provisions of The Regional Parks Act, hereinafter called the "Act".

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the presents and covenants, promises and agreements hereinafter contained, the parties hereto jointly and severally agree as follows:

1. The parties agree to associate and work together to elect a Regional Park Authority and to create the park in accordance with the provisions of The Regional Parks Act and Regulations.
2. To maintain and operate as a regional park until a Regional Park Authority is appointed by the parties and constituted under the Act, all those parcels of land described as follows:

See schedule attached (Schedule "A")

3. The parties agree that there shall be no liability arising from this agreement for the cost of operating or maintaining the park after five (5) years from April 1, 1972.
4. The parties each agree to make annual grants under Section 14 of the Act to share:
  - a) maintenance costs of the park
  - b) capital costs of proposed development of the park up to a maximum of  
in any one year over a period of five years from the date as shown in Section 3, in the following proportions:

5. Each party agrees to designate one or more representatives to act with the other representatives named by the parties in order to conduct preliminary negotiations and the preparation of plans for the park and to prepare a submission for assistance under Section 6 of the Act.
6. The parties agree to perform and do all acts necessary in order to ratify and confirm this agreement and in particular the parties agree to pass a complementary bylaw authorizing the execution and performance of this agreement.

7. This agreement shall be renewable at the end of five years should the municipalities participating under this agreement so desire.

Legal description of Land.

FIRSTLY : All that portion of the North East Quarter of Section  
TWENTY ONE ( 21 ),  
in Township FIFTEEN ( 15 ),  
in Range EIGHTEEN ( 18 ),

West of the Third Meridian, in the Province of Saskatchewan, in the  
Dominion of Canada, which is not covered by any of the waters of a  
certain surveyed lake at the time of the survey of the said lake as  
shown upon a Map or Plan of Survey of the said Township, approved  
and confirmed at Ottawa on the 25th day of January, A.D. 1888,  
containing One Hundred and Fifty Eight ( 158 ) acres, more or less.

SECONDLY: The West Half of the North West Quarter of Legal  
Subdivision Thirteen ( 13 ),  
of Section TWENTY TWO ( 22 ),  
in said Township and Range,

as shown upon a Map or Plan of Survey of the said Township approved  
and confirmed at Ottawa on the 20th day of October, A.D. 1920,  
containing Five ( 5 ) acres, more or less.
